

Since 1986, the Acholi people of northern Uganda have lived in the crossfire of a violent civil war, with the Lord's Resistance Army and other groups fighting the Ugandan government. Acholi have been murdered, maimed, and driven into displacement. Thousands of children have been abducted and forced to fight. Many observers have

perceived Acholiland and northern Uganda to be an exception in contemporary Uganda, which has been celebrated by the international community for its increased political stability and particularly for its fight against AIDS. These observers tend to portray the Acholi as war-prone, whether because of religious fanaticism or intractable ethnic hatreds. In *Living with Bad Surroundings*, Sverker Finnström rejects these characterizations and challenges other simplistic explanations for the violence in northern Uganda. Foregrounding the narratives of individual Acholi, Finnström enables those most affected by the ongoing "dirty war" to explain how they participate in, comprehend, survive, and even resist it.

In recent decades, claims have increasingly been made on trans-national corporations to take responsibility for the promotion and protection of human and labour rights in countries where they operate or otherwise conduct business. This change in the expectations on the behaviour of companies results from the persistent advocacy of non-governmental organizations commonly labelled corporate social responsibility.

This study is about the development of corporate social responsibility understood as a new international norm and how this norm has become an issue on the international agenda.

With a point of departure in the 1970s, different stages of norm emergence, "norm cascade" and norm internalization of corporate social responsibility are traced through five selected non-governmental organizations.



This book is a report of 12 years of research and deals with the life and work of the Swedish artist and experimental film-maker Viking Eggeling. He was active in Paris, Zurich and Berlin, and he was one of the pioneers in the field of abstract, animated film. Also

he was the only Dadaist of Swedish origin. This is the first biography to be written of Viking Eggeling. The material presented has been

gathered from public and private archives in Europe and in the USA.

As a work on art history, the book will be of great value to all interested in the Dada movement in Zurich, Berlin, Munich and Paris from 1916 until around 1922. It will also be valuable to anyone interested in the abstract art whose exponents are Kandinsky and Malevich. Besides introducing a large body of new material, the author corrects some erroneous opinions concerning Eggeling's relation to the Dada movement and revises the data of several events and particular aspects within the history of early abstract, animated film.

In this book 14 scholars get new data and make careful analysis of the partnership organisation both in theory and in practice. They analyse the effectiveness of the partnership organisation in implementing changes and innovation with long-term effects rather than short-term results. The ambition is to address practical dilemmas and problems in the partnership organisation by using different theoretical perspectives – theories about organisational learning, strategies for change, power and empowerment, gender analysis, governance and participation etc. The research presented is valuable in order to achieve deeper understanding of the pros and cons with the partnership organisation. The aim of this dissertation is to study the technological and cultural reach of internationally syndicated radio from the vantage point of the radio programme Solid Steel between 2000 and 2006. Solid Steel is a weekly two-hour music show originally produced and aired in London but today also broadcast by a large number of stations around the world, as well as via the Internet. The theoretical interest of the study lies in the tension and separation between communication as transmission and communication as ritual, as distribution in space and maintenance in time. This separation produces a number of subsequent conceptual pairs; technology and culture, material and symbolic, space and time, etc. Based upon these pairs the study explores the spatial and temporal organization of Solid Steel.

This dissertation looks at event organising from a resources perspective. Which resources are engaged, and how do they contribute? Key questions that emerge concern the event's connection to the place where it is held, how different actors are included or excluded and finally how the aesthetic aspects of an event attract resources.



When Axel Oxenstierna, Chancellor of Sweden, died in 1654, Sweden was a great power. In 1612, however, when Oxenstierna took office, Sweden was on the verge of collapse. In the east, she was menaced by Muscovy, in the southeast by Poland, and in the west by Denmark. One of the means to save the Swedish realm was through active diplomacy. Two important figures in Oxenstierna's diplomatic network were the Scottish officer Sir James Spens (d. 1632) and the Dutch humanist and jurist Jan Rutgers (d. 1625), who played central roles in Swedish foreign politics in the crucial period 1613–1632, i.e., from the disastrous peace with Denmark to Sweden's entry into the Thirty Years' War.



Spens served as Swedish ambassador in London and as Stuart ambassador to Gustav II Adolf.

Rutgers served as Swedish representative in the Dutch Republic and as emissary to North German princes.

Spens' and Rutgers' letters are edited with introductions, summaries, notes and index in English. Two letters by Spens are in Scots.



In this book, the author analyzes the role that the Nordic-Baltic region has played in US strategy in the 60 years since the end of World War II. How has the US viewed the strategic and political situation in the Nordic—and from the end of the Cold War, the Nordic-Baltic—region? What role will the region



play in future US policy, as this becomes increasingly preoccupied with problems far from the shores of the Baltic Sea? Nowhere is the transformation of the international system more striking than in the destiny of the three Baltic countries—Estonia, Latvia and Lithuania—locked up behind the Iron Curtain as Soviet Republics after World War II, and sovereign members of the Western defense alliance half a century later.



Through a close reading of three monumental works of art—Jacques-Louis David's *The Tennis Court Oath* (1791), James Ensor's *Christ's Entry into Brussels in 1889* (1888), and Alfredo Jaar's *They Loved It So Much, the Revolution* (1989)—Stefan Jonsson launches a unique investigation into an age-old dilemma: How do artists fashion a truthful representation of “the people”? Addressing, respectively, The French Revolution of 1789, Belgium's proletarian messianism in the 1880s, and Eastern Europe's Velvet Revolutions of 1989, these works depict not only an alternative view of history, Jonsson argues, but capture the very essence of democracy.

Drawing on examples from literature, politics, philosophy, and additional pieces of art, Jonsson's research reveals surprising parallels between the people's political representation (in government) and their aesthetic representation (in painting). Both essentially “frame” the people, defining them as elites or masses, responsible citizens or angry mobs. Yet in the aesthetic fantasies of David, Ensor, and Jaar, Jonsson finds a different understanding of democracy—one in which human collectives are able to break the frame and enter the picture. *A Brief History of the Masses* is at once a cultural history and a contemporary discussion about the fate of democracy in our globalized world. Jonsson connects the achievements and failures of past revolutions to current political issues and situates our present moment in a long historical drama of popular unrest.





Some of the papers in this volume are formed by the "postmodern" view of gender issues, notably: the shaping of identity in relation to gender and roles in present-day Czech talk shows (Tora Hedin), the representation (or rather, underrepresentation) of women in a 14th century French chronicle (Per Förne-gård), and a socio-semiotic discourse analysis of gender roles in gardening manuals, especially in the 19th century (Andreas Nord). The two literary contributions deconstruct their texts in a similar manner. Catherine Sandbach-Dahlström argues that Virginia Woolf's textual practice in *Three Guineas* is determined by her "Bakthian" sense of the complications inherent in the polyphony of utterances already infected by intentions of other. Anna Udden's scrutiny of 18th century reviews reveals how gendered prejudices are shaped by textual strategies and result in insensitivity to innovation in the writings of women writers. This is most blatantly evidenced in the condescending reception by contemporary critics of Jane Austen's *Emma*, now of course recognized as one of the major works of the nineteenth century. A rather different perspective is taken by Bettina Jobin and Eva Lindström who both view gender from a grammatical perspective. Jobin looks at the gender system in German, and Lindström at the acquisition of gender agreement in L2 French.







Trust is a crucial element in business relationships. The early internationalization of a firm is interesting as a context for studying trust-building processes for several reasons. The internationalization is related to risks just as trust is. New business relationships are opened up, situations in which trust is a critical element. But internationalization is also connected to circumstances wherein trust-building is particularly challenging to achieve.

This dissertation increases understanding of the process of trust-building in a firm's early internationalization. It represents a view where trust is not an irrational act but a manageable act of faith in people, relationships, and social institutions. The communication of trustworthiness is argued to be one of the critical empirical problems in the early stages of starting up a relationship with a party on a new market. To manage this communication an ability to communicate must be fine-tuned along the way. Trust-facilitators in the form of organizations and individuals can also strategically be used to strengthen the trust-building process.



This book explicates a reflective lifeworld research approach, based on phenomenological philosophy. serves as a guiding principle for research. The approach originates from the aim of allowing the phenomenon to guide the research by which the phenomenon and its meanings will

be illuminated, understood and explicated, and is supported by an open and "bridled" attitude to the phenomenon and the research. Based on a solid epistemological presentation and ideas about how an open and "bridled" approach can be established, some methodological principles are outlined for data gathering as well as for descriptive and interpretive data analysis, respectively. This study addresses the puzzle why Pierre Mendès France as French Prime Minister managed to grant Indochina independence through negotiations, but neglected the same demand from Algeria. In the mid-1950s, France was experiencing not only a political crisis but also a crisis of national identity. The

author shows that there were competing national identities among the French foreign policy elite, and that the struggle among different identity conceptions was a determinant factor in the outcome of the Indochina and Algeria cases. Pierre Mendès France tried to decolonize France by making France a European power. This seemed successful when France left Indochina, but it turned to be a failure when Algeria demanded its independence. The research material represents a unique collection of speeches, letters, radio performances, opinion polls, media debates and internal working papers.




The book argues that the high mobilization potential of the supra-national extremist ideology inspired by al-Qaeda cannot be effectively counterbalanced at the global level by either mainstream secular global ideologies or moderate Islam. Instead, it is more likely to be affected and transformed by radical nationalism. Unless the political transformation of violent Islamist movements in specific national contexts is encouraged and the transnational ideology of violent Islamism is 'nationalized', it is unlikely to be amenable to external influence or to be destroyed by repression.





The dissertation argues that, although the policy discourse early on established that inducing safer sex practices among the Swedish population was the only viable solution to the pandemic, the discourse is nonetheless permeated by notions of unsafe identities. The dissertation also stresses the importance of scrutinizing HIV/AIDS policy in light of broader political developments, and argues that an increasing focus on migrants in HIV/AIDS policy should not be seen as a simple reflection of the global epidemiological development, but should rather be understood in relation to the general political and economic phenomenon of welfare state retrenchment.



This thesis is a timely contribution to ethnological analysis of sexuality among Iranian women. Considering sexuality as gendered and socioculturally constructed, Fataneh Farahani examines the impact of Iranian Islamic discourses and contemporary socialization, as well as diasporic experiences, on women's

narrations of sexuality. With sexuality as the main subject of analysis, the writer focuses on issues involving gender, otherness, agency, and marginality. Being alert to different (sometimes contradictory) discourses, Fataneh Farahani studies the tension that develops between the process of (self)disciplining women's bodies and the coping tactics that women employ.

The writer shows how moral values regarding appropriate sexual behavior undergo various and sometimes contradictory transformations. The interviewees report being torn between two 'seemingly' different cultures, each constructed discourses filled with stereotypes of so-called natives and outsiders. The writer shows that, in their everyday lives amidst a variety of racist and sexist stereotypes, women are not really 'torn between two cultures.' Rather, they live a hybrid experience of 'Swedishness' and 'Iranianess' along with other characteristics. At issue is a complexity within the culture(s) in which they live.


