

# SWEDISH ACADEMIC BOOKS

In the previous issue of SAB we presented a summary of the new “Research and innovation bill” announced by the Swedish government in October last year. The research bill was more than double as large as any of its predecessors, but was met with criticism by some scholars within the humanities who claimed that the bill was disadvantageous to their subject fields.

The bill reserves the largest increases to “strategic basic research” in medicine, technology and the climate. Research in humanities and social sciences will also receive higher appropriations than before, with emphasis on research dealing with the mechanisms of economic growth.

Critics to the government’s bill mean that in these days of global financial crisis, there is an exaggerated faith in single sided technical and economic solutions. Not only is there a lack of technical, medicinal and economic knowledge, bus also – and perhaps even more so – a lack of ability to handle this knowledge. Hence commitment to the humanities and social sciences should be equally important.

However, the Swedish Minister for Higher Education and Research says that the bill is widely acclaimed by the research community and defends the bill’s focus on combining basic research and innovations with economic growth; the ambition is to put Sweden on the map of prominent research and innovation by gathering up results from research and combining it with politics that promotes job opportunities.




The Visible and the Invisible: Color Contrast Phenomena in Space deals with the changes in color that arise in space, primarily simultaneous contrast in three dimensions.

The typical account of simultaneous contrast is that the contrast phenomenon occurs between two or more areas of color seen together, which thus affect one another.

The book broadens this view and traces the history and theory of contrast phenomena from antiquity to the present age. The Visible and the Invisible explores color contrast phenomena in a context of visual culture and aesthetics, in architecture and in art.

Early modernism manifested an interest in color contrasts and perception, which lead the way to a new interdisciplinary outlook on vision and simultaneity. 





*Personnel Reductions at the Swedish Tobacco Monopoly, 1915-1939*

Downsizing is a phenomenon that remarkably seldom has been the subject of historical inquiry. This study investigates how a state-owned enterprise, the Swedish Tobacco Monopoly, reduced its labour inputs because of changed consumer preferences and mechanization in the 1920s and 1930s. By combining qualitative and quantitative evidence, the study addresses questions about the ways of achieving

reductions, categorization of workers and decision-making.

It is shown that most of the reduction was achieved by reducing the number of workers. Attrition, early retirements and buyouts accounted for about half of the reduction and layoffs for the other half. The management initially made cuts at both ends of the age distribution, but with the advent of mechanization, downsizing measures became more focused on older workers and the principle 'last in, first out' was abandoned in favour of a more need-based approach to layoffs. This policy shift was associated with an increased inclination of the management to involve the union in establishing the order of selection, which was a dilemma for the union leaders.

In London in 1848 a group of young artists rallied together under the name of Pre-Raphaelites. economy was decided. In the years 1985–1989 the economists defended the socialist theoretical system and attacked the central aspects of the market economy. If certain ideas and principles of market economics were deemed as functioning methods, it was argued that these could be integrated within the socialist system. The conclusion is that the Soviet economists failed to solve some central theoretical problems in the Soviet economy. Their thinking did not have a stabilizing effect on the dominating socialist theory.

In 1990 and 1991 market economic principles started to dominate the debate. The issue became gradual transition to a market economy

or "shock therapy". Scholars have emphasized that stationary structures are important in Russian and Soviet history. It can be argued that such structures played a role also in the Soviet economists' thinking. For example, the idea to create a socialist market could be interpreted as a result of stationary structures, namely the personalization of economic exchange.



Political decision making can be analyzed through a plethora of theories. Here Economic Psychology is used as theoretical framework to analyze decision making, both by politicians and voters.

The thesis consists of an overview of current research; an econometric study of how the voters in municipal elec-

tions react to changes in fiscal policy; and two case studies where the transfer of responsibility from one political level to another are studied, namely the transfer of Elder Care from counties to municipalities, and the transfer of the school system from the national government to the municipalities.

It is shown that political actors often take psychological factors into consideration when they design or react to policy proposals. It is also shown the use of a psychological approach can improve the understanding of political decision making, particularly when the processes are complex or involve negotiations.

Change is a necessity for organisations due to for instance technological development and global competition. For managers at different hierarchical levels monitoring change is a big challenge besides their responsibilities for operating business and subordinates' health.

John Ylander shows in his study how change in three units in a large corporation results in a lot of diverging processes. Different time perspectives and different discourses often lead to confusion and lost trust.

However, some constructive action was identified. Stabilising relations and feed-forward reflection were examples and in these cases managers on lower levels initiated such action.

Ylander uses Giddens and his concept Structuration both to understand the emergent complexity in change and to form guidelines that could help managers synchronising processes more constructively.



Jews in Latvian literature have traditionally been portrayed as essentially different, although generally not in a negative sense. With the establishment of Latvian independence after the First World War, and particularly during the years of authoritarian rule under Karlis Ulmanis, nationalism became an ever stronger force in society. A Latvian national discourse prevailed in which a particular focus on ethnic 'others' was central. This discourse also brought about a change in the perception of, and attitudes towards, Jews as reflected in Latvian literature.

Anette Reinsch-Campbell investigates a Corpus of Latvian novels published between 1934–1944, i.e. during three different non-democratic regimes: authoritarian and nationalistic (1934–1940), the first Soviet occupation (1940–1941) and the Nazi occupation (1941–1944). What images of Jews are conveyed in literature produced during these regimes and what is the impact of such phenomena as modernity, ethnocentrism, nationalism and anti-Semitism?

In Essay I, the time-series dynamics of liquidity on the Scandinavian stock exchanges between January 1993 and June 2005 are studied with liquidity indices. We observe that on all Scandinavian stock exchanges, liquidity has increased during the examined period.

Essay II evaluates 14 macroeconomic variables' ability to forecast changes in monthly liquidity on the Scandinavian order-driven stock exchanges.

Essay III examines whether the pairwise comovement between stocks quoted on the Stockholm stock exchange can be correctly quantified by the Gaussian copula, i.e., by linear correlation.



The purpose of this dissertation is to examine to what extent the dramatic work of Bernard-Marie Koltès could serve as a basis for ethical reflections. The main object of the study is Koltès' construction of his characters by certain

Duras's literary work. The study shows that water has multiple functions in these texts: it is linked to major themes and creates an enigmatic atmosphere by its association with the unknown, the inexplicable and the unconscious. The strong presence of water in Duras's texts is striking. References to the water element can be found in several titles throughout her career, from early works such as *Un barrage contre le Pacifique* (1950) to *La mer écrite* (1996), published just after her death. Almost all of her fiction take place near water and the rain or the sound of waves serve as leitmotifs in specific novels. The water motif can play a metonymic as well as a metaphoric role in the texts and it sometimes takes on human or animalistic characteristics. Several emblematic Durassian characters (e.g. the beggar-woman, Anne-Marie Stretter and Lol V. Stein) have a close relationship to water. The water motif is linked to many major Durassian themes, and illustrates themes with positive connotations, for example, creation, fecundity, maternity, liberty and desire, as well as themes with negative connotations such as destruction and death.

Finally, the role of the water element in psychoanalytic theory is discussed (Chapter 8), and a parallel is drawn between the Jungian concept of the mother archetype and the water motif in Duras's texts. The suggestion is made in this last chapter that water is used to illustrate an oriental influence (Taoist or Buddhist) of some of the female characters in Duras's work.





This study investigates the topic of forgiveness of sins in the mission of the historical Jesus. Gospel material that pertains to the question is authenticated by the use of criteria for historicity and interpreted within the wider context of first-century Judaism as part of a broader reconstruction of Jesus' career as a healer and prophet. Questions posed and answered concern the historical plausibility of the Gospel accounts of how Jesus purported to forgive sins, the meaning that such an activity would have conveyed to his contemporaries, and its implications for his identity. The method combines criteria conventional to historical Jesus research with a tradition-historical analysis informed by ancient progymnastic rhetoric. Jesus' announcement of forgiveness is found to be attested across multiple sources, dissimilar to primitive Christian theology, and coherent with his activity as a healer and prophet. All this speaks in favour of the basic historicity of the topic. The study suggests that Jesus was guided by his distinctively literal interpretation of the Book of Isaiah's eschatological prophecies to announce God's forgiveness as part of his own mission as the Prophet-Messiah. At the same time, the alleged controversy over forgiveness between Jesus and his adversaries includes elements that are implausible within a first-century Jewish setting and incoherent with

historical Jesus traditions. An analysis of Mark 2.1-12 with the help of ancient textbooks suggests progymnastic rhetoric as the force behind the elaboration of this episode. The results carry implications for the understanding of how the gospel tradition developed, for the formulation of the criterion of discontinuity, and for the recognition of Jesus' place within early Judaism as marked by both contextual appropriateness and contextual distinctiveness.





Post-Soviet Azerbaijan is often portrayed as a very secular country. Thus the mobilization of mosque communities in the late 1990s and their conflictual relationship with the authorities came as a surprise. The main aim of the dissertation is to shed light on this mobilization, focusing on the Sunni Abu Bakr and the Shi'ite Juma mosque communities in Baku. On the premise that Islamic mobilization may be interpreted as a "social movement", internal, contextual and interactional aspects of mobilization have been studied. The analysis is chiefly based on interviews conducted in Baku in 2004/2005 with Imams, worshippers, religious and secular authorities.

The thesis concludes that the role of the state in mobilization processes in non-democratic contexts is crucial but counterintuitive, as the regimes' efforts to stop the mobilization of movements actually leads to its intensification. In Azerbaijan, official pressure brings community members closer together and strengthens their resolve, rather than putting an end to mobilization. It also puts a spotlight on these communities which lights up the way for others in search of something new.
